1. This is a Contract between *Pooch Pad* (hereinafter called "Kennel") and the pet owner whose signature appears below (hereinafter called "Owner").
2. Owner agrees to pay the rate for boarding in effect on the date pet is checked into the kennel.
3. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the time said pet is in the care of Kennel.
4. Owner further agrees that the pet shall not leave Kennel until all charges are paid to Kennel by Owner.
5. By signing this Contract and leaving said pet(s) with Kennel, Owner certifies that the information given about said pet(s) is known to be accurate to the best of owner knowledge.
6. When older pets are boarded they are placed under a great deal of stress because of removal from their normal home environment. This stress can cause latent (dormant) physical conditions (such as heart, liver and kidney disorders) to become active. This can result in illness or death of said pet.
7. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.
8. Owner specifically represents to Kennel that the pet has not been exposed to rabies, distemper, parvo virus, feline leukemia or other contagious diseases within a thirty day period prior to boarding.
9. All charges incurred by Owner shall be payable upon pick-up of pet, or when billed by Kennel at the address listed on Contract. Kennel shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding the pet at Kennel. If Owner does not pick up the pet within 15 calendar days after the day the pet was due to be picked up, the pet shall be deemed to be abandoned. The person into whose custody the pet was placed for care shall first try for a period of not less than 10 days to find a new owner for the pet, and, if unable to place the pet with a new owner, shall thereafter determine the pet to be abandoned.
10. If the pet becomes ill or if the state of the pet's health otherwise requires professional attention, the Kennel, in its sole discretion, may engage in the services of a veterinarian or give other requisite attention to the pet. Any expenses thereof shall be paid by Owner.
11. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of Owner and Kennel.
12. Any controversy or claim arising out of or relating to this Contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this Contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of this award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
13. I give permission for my dogs picture to be posted on Pooch Pads social media or website page.
14. I am aware that my dog will be interacting with other dogs during their time at this facility.
15. I understand Pooch Pad is not liable for pets lost/damaged personal items. I. E.. toys, blankets, etc
